

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF DEANS GREEN, HENLEY IN ARDEN

Warwickshire County Council proposes to make a Temporary Traffic Order closing Deans Green, Henley in Arden, from the side of the junction of Hall End Road to the junction of Mill Lan, to vehicular traffic. The closure is required to facilitate utility works for the clearance of blockages.

The Order will commence on 29 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 12 May 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Deans Green, White Pump Lane, Ramshill Lane, Mill Lane (and vice versa).

TEMPORARY CLOSURE OF HENLEY ROAD, CLAVERDON

Warwickshire County Council has made a Temporary Traffic Order closing Henley Road, Claverdon, from a point adjacent to The Crown Inn, to vehicular traffic. The closure is required to facilitate works to rectify a defect in the carriageway.

The Order will commence on 7 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 7 April 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Station Road, Gannaway Road, Gannaway, Henley Road, Watery Lane, Hampton Road, A46 Sherbourne Roundabout, Sherbourne Hill, A46 from Sherbourne Roundabout to Exit at Sherbourne S, A46 Through Entry/exit At Sherbourne S, A46 From M40 J15 To J A439 Sw, A46 From J A439 To M40 J15 Ne, Stratford Road, A46 J A439 Roundabout, Warwick Road, A46 From J A3400 To J A439, Stratford Northern Bypass, Ingon Lane, A46 J A3400 Roundabout, A46 From J A422

To J A3400, A46 J A422 Roundabout, Alcester Road, A46 from J A435 to J A422, Alcester Bypass, Norton Lenchwick Bypass, A46 J A435 Roundabout, Birmingham Road, Coughton Hill, Haydon Way, Priory Square, Redditch Road, Oldberrow Road, Oldberrow Lane, Hunger Hill, New Road, Blackford Hill, Whitley Hill (and vice versa).

TEMPORARY CLOSURE OF D5250 STAR LANE, CLAVERDON

Warwickshire County Council has made a Temporary Traffic Order closing D5250 Star Lane, Claverdon, from its junction with Manor Lane to its junction with Lye Green Road, to vehicular traffic. The closure is required to facilitate carriageway patching works.

The Order will commence on 9 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 9 April 2019.

PLEASE NOTE: It is anticipated that works will be carried out between 08.00hrs and 16.00hrs and that the road will re-open outside of these hours.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Lye Green Road, The Green, Station Road, Star Lane and vice versa.

TEMPORARY CLOSURE OF HIGH STREET, BIDFORD ON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing High Street, Bidford on Avon to vehicular traffic. The closure is required to safely facilitate works for the installation of poly duct in the carriageway and verge.

The Order will commence on 23 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 25 April 2019.
