# TEMPORARY CLOSURE OF PUBLIC FOOTPATHS SS2A AND SS2 IN THE PARISH OF PILLERTON HERSEY

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpaths SS2a and SS2, Grid Reference 29719 249327, to all traffic. The closures are required to avoid the likelihood of danger to the public because of a collapsed bridge.
