

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF KINGTON ROAD, CLAVERDON**

Warwickshire County Council proposes to make a Temporary Traffic Order closing Kington Road, Claverdon to vehicular traffic. The closure is required to safely facilitate tree trimming works.

The Order will commence on 10 June 2019 and will last for a period of 18 months, or until the works are completed in one day on 10 June 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## **TEMPORARY CLOSURE OF MILCOTE ROAD, WELFORD ON AVON**
