ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF D6568 LONGDON ROAD, DARLINGS SCOTT

Warwickshire County Council has made Temporary Traffic Order closing D6568 Longdon Road, Darlingscott, from its junction with the B4035 Campden Road to Darlingscott Road, to vehicular traffic. The closure is required for carriageway resurfacing & associated works.

The Order will commence on 24 June 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 12 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Darlingscott Road, Village Road, A429 Fosse Way, B4035 Camden Road and vice versa.

TEMPORARY CLOSURE OF UNION STREET, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing Union Street, Stratford Upon Avon from a point outside number 22 to the junction with Bridge Street, to vehicular traffic. The closure is required for works to replace a defective manhole cover and frame.

The Order will commence on 23 June 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 23 June 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Union Street, Guild Street, Warwick Road, Bridgeway, Bridgefoot, Bridge Street, Market Cross, Birmingham Road, Windsor Street, Wood Street (and vice versa).

THE WARWICKSHIRE COUNTY COUNCIL (A429 FOSSE WAY/B4035 CAMPDEN ROAD) (50 MPH SPEED LIMIT) (VARIATION NO. 1) ORDER 2019

Warwickshire County Council propose to make the above Order under the Road Traffic Regulation Act 1984 the effect of which will be to impose a 50mph speed limit on the length of road mentioned in the Schedule below.

A copy of the proposed Order, together with a plan showing the length of road affected and a statement of the Council's reasons for proposing to make the Order, may be inspected at the Main Reception, Shire Hall, Market Place, Warwick, at the Stratford on Avon District Council, Elizabeth House, Church Street, Stratford-upon-Avon, Warwickshire, CV37 6HX and at the Public Library, 12 Church Street, Shipston-on-Stour, CV36 4AP during usual opening hours.

SCHEDULE 1 **(Proposed 50mph Speed Limit)**

1. A429 Fosse Way

From a point 302 metres north of its junction with B4035 Campden Road to a point 313 metres south of B4035 Campden Road.

2. B4035 Campden Road

From a point 73 metres west of its junction with Sadlers Avenue, south-westwards to a point 250 metres west of its junction with A429 Fosse Way.
