

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF OXHILL BRIDLE ROAD, PILLERTON HERSEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Oxhill Bridle Road, Pillerton Hersey to vehicular traffic. The closure is required for the installation of electricity cables to enable removal of overhead lines.

The Order will commence on 15 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Oxhill Bridle Road, Ford Lane, Kineton Road, Halford Road (and vice versa).

TEMPORARY CLOSURE OF D6490 AVON CLOSE, ETTINGTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing D6490 Avon Close, Ettington from its junction with A422 Banbury Road to its junction with Avon Fields to vehicular traffic. The closure is required for footway reconstruction works (0800 hrs to 1700 hrs weekdays only).

The Order will commence on 15 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 22 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Access to Avon Fields will be maintained.

TEMPORARY CLOSURE OF D6549 COMPTON SCORPION ROAD, ILMINGTON

Warwickshire County Council made a Temporary Traffic Order closing D6549 Compton Scorpion Road, Ilmington, from its junction with Featherbed Lane to its junction with Compton Scorpion Lane, to vehicular traffic. The closure was required to facilitate drainage works.

The Order commenced on 4 February 2019 for a period of 18 months, or until the works were completed, whichever was the earlier. Unfortunately, the works did not proceed as planned. However, the works have now been rescheduled to commence 8 July 2019 for 5 days between 08.00hrs and 17.00hrs daily.
