

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF LONG MARSTON ROAD & MILCOTE ROAD, WELFORD ON AVON

Warwickshire County Council has made a Temporary Traffic Order closing Long Marston Road, Welford on Avon, between points approximately 40 metres north and 20 metres south of its junction with Milcote Road and closing Milcote Road, Welford on Avon, from its junction with Long Marston Road for a distance of approximately 200 metres, to vehicular traffic.

The closures are required for further Section 278 Junction Improvement Scheme works, 08.00 to 18.00 daily.

The Order will commence on 17 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed on 18 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of roads to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Long Marston Road, Milcote Road, Weston Sands, Station Road, Clifford Road, Shipston Road, Stratford Road, Fosse Way, A429 County Boundary to Aston Magna Junction, A429 Aston Magna Junction to Batsford Junction, High Street, Oxford Street, Bourton Road, A44 from Bourton Road to Five Mile Drive, 3/112 Road joining A424 and A44 Bourton On The Hill, Five Mile Drive, Road From Five Mile Drive to Broadway Hill, Broadway Hill, Fish Hill, Broadway Bypass, Evesham Road, Pitchers Hill, Longdon Hill, Broadway Road, A46 Evesham By Pass, A46 J A44 Roundabout east of Evesham, A46 From J A44 east of Evesham to J A44 north of Evesham, Badsey Road, Village Street, Birmingham Road, Blackminster, Main Street, Cleeve Road, Bidford Road, Welford Road, Barton Road (and vice versa).

TEMPORARY CLOSURE OF D6240 BROAD STREET, D6243 NEW BROAD STREET, D6238 BROAD WALK, D6241 WEST STREET & D6239 NARROW LANE, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing the above named roads in Stratford upon Avon to vehicular traffic, as indicated below, for carriageway resurfacing.

TEMPORARY CLOSURE THE CYCLE WAY, SEVEN MEADOWS ROAD, STRATFORD UPON AVON

Warwickshire County Council proposes to make a Temporary Traffic Order closing the cycleway west side of Seven Meadows Road toward Sandfield Road, Stratford upon Avon to all traffic. The closure is required for utility works.

The Order will commence on 2 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 4 September 2019.

There is no diversion available and Cyclists are to dismount and use adjacent pedestrian walkway.

TEMPORARY CLOSURE OF PUBLIC FOOTPATH SS32B IN THE PARISH OF TYSOE

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath SS32b in the Parish of Tysoe, at Grid Reference SP34021-450056, to all traffic. The closure is required for the safety of the public because of the dangerous condition of a bridge along its route.

The Order will commence on 23 August 2019 and will last for a period of 6 months, or until the works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained.

An alternative route will be signed and is available via: Land End Lane and Public Bridlepath SS32.

TEMPORARY CLOSURE OF C107 HARROW HILL (LONG COMPTON ROAD), SHIPSTON ON STOUR

Warwickshire County Council has made a Temporary Traffic Order closing C107 Harrow Hill (Long Compton Road), Shipston on Stour, from its junction with A3400 Shipston Road to its junction with Hacks Lane, to vehicular traffic. The closure is required to continue urgent essential drainage works.

The Order commenced on 10 August 2019 for a period of 18 months, or until remedial works are completed, whichever is the earlier.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: A3400 Shipston Road, Hack Lane and vice versa.
