

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF D6345 DOVEHOUSE DRIVE, WELLESBOURNE

Warwickshire County Council has made a Temporary Traffic Order closing D6345 Dovehouse Drive, Wellesbourne, from its junction with Loxley Road to its junction with Hammerton Way, to vehicular traffic. The closure is required for carriageway patching

The Order will commence on 25 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 09.30 and 15.30 on 25 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Loxley Road, Dovehouse Drive and vice versa.

TEMPORARY CLOSURE OF LANGLEY ROAD, CLAVERDON

Warwickshire County Council has made a Temporary Traffic Order closing Langley Road, Claverdon, from the entrance to Woodside to Fieldway, to vehicular traffic. The closure is required for utility works.

The Order will commence on 23 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 4 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Langley Road, Main Street, Ford Lane, Salters Lane, Saddle Bow Lane, Station Road, Church Road and vice versa.

TEMPORARY CLOSURE OF HATHAWAY LANE, STRATFORD UPON AVON

Warwickshire County Council has made a Temporary Traffic Order closing Hathaway Lane, Stratford upon Avon, between properties no. 21 and 23, to vehicular traffic. The closure is required for replacement of a defective manhole cover and frame.

The Order will commence on 26 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on 26 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Hathaway Lane, Evesham Road, Brookvale Road, Shottery Road, Shottery and vice versa.

TEMPORARY CLOSURE OF C31 KINETON ROAD & PILLERTON ROAD, PILLERTON HERSEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing C31 Kineton Road & Pillerton Road, Pillerton Hersey, from Jct. Ford Lane to Jct. Verney Close, to vehicular traffic. The closure is required for carriageway patching, 08.00 - 16.00 daily.

The Order will commence on 8 October 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Halford Road, Kineton Road, A422 Banbury Road, A422 Pillerton Hersey Road, Oxhill Road, Tysoe Road, Kineton Road, Bridge Road, Pillerton Road and vice versa.
