

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **FORDE HALL LANE, ULLENHALL**

**Order effect:** Road closed to vehicular traffic, from a point adjacent to Mockley Manor Care Home.

**Reason for Order:** the connection of new water plots to mains.

**Order Commences:** 29 October 2019 for up to 18 months.

**Anticipated Completion Date:** 31 October 2019.

**Access & Diversion:** Forde Hall Lane, Ullenhall Lane, Alcester Road, Beoley Lane, Broad Lane, Aspley Heath Lane, Blind Lane (and vice versa).
