ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

ALNE HILLS, GREAT ALNE

Order Effect: Road closed to vehicular traffic from a point outside Pipers House to a point outside Newlands.

LOXLEY ROAD, STRATFORD UPON AVON

Order Effect: Road closed to vehicular traffic from its junction with the access road to Arden Heath Farm to the junction with Knights Lane.

Reason for Order: To facilitate drainage works.

Order Commences: 25 February 2020 for up to 18 months.

Anticipated Completion: 16 March 2020.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
