

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

CHURCH ROAD, WILMCOTE

Order Effect: Road closed to vehicular traffic between properties number 19 and 25.

Reason for Order: To facilitate works for the installation of a boundary box.

Order Commences: 28 February 2020 for up to 18 months.

Anticipated Completion: 3 March 2020.

Access & Diversion: The Green, Aston Cantlow Road, Billesley Road, Church Road and vice versa.

A4189 HENLEY ROAD, CLAVERDON

Order Effect: Road closed to vehicular traffic from its junction with Kington Lane to its junction with The Green (Lye Green Road).
