

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### CHURCH STREET, SHIPSTON ON STOUR

**Order Effect:** Road closed to vehicular traffic from a point outside property number 36.

**Reason for Order:** To facilitate works for the repair of a water pipe.

**Order Commences:** 25 April 2020 for up to 18 months.

**Anticipated Completion:** 26 April 2020.

**Access & Diversion:** Church Street, Stratford Road, Shipston Road, Fosse Way, Campden Road, West Street and vice versa.

### MAIN STREET, OXHILL

**Order Effect:** Road closed to vehicular traffic from a point outside Blackford House to a point outside St Lawrence Church.

**Anticipated Completion:** 1 May 2020.

**Access & Diversion:** Vehicular access will be maintained where possible.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

### DITCHFORD ROAD, TIDMINGTON

**Order Effect:** Road closed to vehicular traffic from a point opposite Tidmington Corner to the junction with London Road.

**Reason for Order:** To safely facilitate works for the installation of polyduct in the verge.

**Order Commences:** 29 April 2020 for up to 18 months.

**Anticipated Completion:** 1 May 2020.

**Access & Diversion:** Ditchford Road, Back Lane, Shoulderway Lane, London Road and vice versa.

### KINETON ROAD, FORD LANE & WATERY LANE, PILLERTON HERSEY

**Order Effects:** Roads closed to vehicular traffic as follows:

3. Watery Lane – closed along its entire length from its junction with Kineton Road.

**Anticipated Completion:** 5 June 2020.

2. Ford Lane, Oxhill Bridle Road, Halford Road, Kineton Road and vice versa.

### MANOR ROAD, STRETTON ON FOSSE, MORETON IN THE MARSH

**Order Effect:** Road closed to vehicular traffic.

**Access & Diversion:** Cross Lane, School Lane, Main Street, Manor Road and vice versa.
