## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **GOOSE LANE, UPPER QUINTON**

**Order Effect:** Road closed to vehicular traffic from a point outside the junction with Hill Lane.
