## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### ALNE HILLS, GREAT ALNE

**Order Effect:** Road closed to vehicular traffic from a point outside Newlands to a point outside Piper's House.

**Reason for Order:** To facilitate utility works.
