

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### A3400 STRATFORD ROAD, TANWORTH IN ARDEN, LAPWORTH & HENLEY IN ARDEN

**Order Effects:** Speed Limits on A3400 Stratford Road as indicated below:

30 mph Temporary Speed Limit – from a point 30 metres south of D5021 Nuthurst Road to a point 850 metres south of D5017 Wharf Lane, and

10mph Temporary Speed Limit (Convoy Working) – from a point 330 metres north of D5021 Nuthurst Road to a point 155 metres north of X5019 (D5019 Stopped up) Lapworth Grange Road.

**Reason for Order:** For the safety of all road users and of the contractors whilst carriageway resurfacing and associated works are being carried out using convoy working.

**Order Commences:** 24 August 2020 for up to 18 months.

**Anticipated Completion:** 27 August 2020.

### C166 ROLLRIGHT ROAD (OLD HILL), LONG COMPTON

**Order Effect:** Road closed to vehicular traffic from its junction with the A3400 Oxford Road to its junction with Old Hill Lane.

**Order Commences:** 27 August 2020 for up to 18 months.

### D6336 KINETON ROAD, D6330 WILLOW DRIVE, D6335 BIRCH GROVE, WELLESBOURNE

**Order Effect:** Roads closed to vehicular traffic as follows:

D6336 Kineton Road – closed in its entirety between both its junctions with the B4086 Kineton Road,

D6330 Willow Drive – closed in its entirety from its junction with D6336 Kineton Road to its junction with School Road,

D6335 Birch Grove – closed in its entirety (cul-de-sac).

**Reason for Order:** Carriageway resurfacing and associated works, 09.00hrs-15.30hrs daily excluding weekends and bank holidays.

**Order Commences:** 20 August 2020 for up to 18 months.

**Anticipated Completion:** 2 September 2020.

**Access & Diversion:** Access to the following will also be restricted whilst works are being carried out: Linden Avenue, Sycamore Close, Brookside Avenue, Ash Tree Close.

### QUEEN STREET, HALFORD

**Order Effect:** Road closed to vehicular traffic between its northerly and southerly junctions with Fosse Way.

## THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, LITTLE ALNE) (30 MPH SPEED LIMIT) ORDER 2020

From its junction with the B4089, south for a distance of 40 metres.

## THE WARWICKSHIRE COUNTY COUNCIL (B439, BIDFORD ON AVON) (30 & 40 MPH SPEED LIMIT) (VARIATION NO. 1) ORDER 2019

Warwickshire County Council has made the above Order under the Road Traffic Regulation Act 1984, the effect of which will be to remove the 40mph speed limit and extend the 30mph speed limit on the length of road mentioned in the Schedule below.
