## SITE ALLOCATIONS PLAN

The District Council has prepared a Site Allocations Plan Development Plan Document which is an additional plan that will sit alongside the adopted Core Strategy, and will enable residents, businesses and communities to know where new development may occur in the future.

The Plan includes a range of proposals across the District relating to:

- Reserve Housing Sites
- Self and Custom Build Housing sites
- Built-up Area Boundaries
- Employment Enabling Sites
- A46 Safeguarding Plus a number of other site specific proposals including sites for employment and regeneration Preparing the Plan involves a number of stages, Preferred Options is essentially

the draft stage. Further consultation on the final draft (Proposed Submission version) is expected in 2021 before the Plan is submitted to the Government for independent examination. The Preferred Options Site Allocations Plan is subject to a 7-week period

of public consultation running from Thursday 29 October to 5pm on Friday 18 December 2020, Stratford-on-Avon District Council is inviting representations on the Plan and its supporting evidence.
