

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **ADMINGTON ROAD, SHIPSTON ON STOUR**

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To facilitate works for a new water connection.

**Order Commences:** 16 November 2020 for up to 18 months.

**Anticipated Completion:** 18 November 2020.

**Access & Diversion:** Admington Road, Stratford Road, Mickleton Road, Park Lane, Admington Lane and vice versa.

Access to residents and businesses only.

### **D6311 REDHILL ROAD, LOXLEY**

**Order Effect:** Road closed to vehicular traffic from its junction with the A429 Ettington Road (Redhill) to its junction with Wellesbourne Road.

**Reason for Order:** Carriageway patching and associated works, 08.00hrs-16.00hrs.

**Order Commences:** 13 November 2020 for up to 18 months.

**Anticipated Completion:** In one day on 13 November 2020.

**Access & Diversion:** Wellesbourne Road, Loxley Road, A429 (Wellesbourne Bypass, Redhill, Ettington Road) and vice versa.

### **D6478 FORD LANE, PILLERTON HERSEY**

**Order Effect:** Road closed to vehicular traffic from its junction with Kineton Road to its junction with Oxhill Bridle Road.

### **SHEEP STREET, SHIPSTON ON STOUR**

**Order Effect:** Road closed to vehicular traffic from a point outside property number 26, The Cottage.

**Anticipated Completion:** 19 November 2020.

**Access & Diversion:** Sheep Street, Market Place, High Street and vice versa.

### **SHELFIELD GREEN, ASTON CANTLOW**

**Order Effect:** Road closed to vehicular traffic from a point opposite Park Farm.

**Reason for Order:** To safely facilitate utility works.

**Anticipated Completion:** In one day on 18 November 2020.

**Access & Diversion:** Shelfield Green, Burford Lane, Shelfield Green Lane and vice versa.

### **SPERNAL LANE, ALNE END**

**Order Effect:** Road closed to vehicular traffic between the junctions of Burford Lane and School Road.

**Reason for Order:** To facilitate cabling & splicing works.

**Access & Diversion:** Spernal Lane, Spernal Lane, School Road, Captains Hill, Kinwarton Road, Kinwarton Farm Road, Tything Road West, Arden Road, Birmingham Road, Coughton Hill, Haydon Way and vice versa.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

### **A429 FOSSE WAY, HALFORD & A429 FOSSE WAY, TREDINGTON**

**Order Effect:** Road closed to vehicular traffic from A429/B4455 roundabout to its junction with C49 Halford Road. In addition, a 30mph speed restriction will be imposed between A429/B4455 roundabout and the A429/A3400 roundabout.

**Reason for Order:** To safely facilitate carriageway resurfacing and associated works, 09.00hrs-15.30hrs.

**Order Commences:** 26 November 2020 for up to 18 months.

**Anticipated Completion:** 9 December 2020.

**Access & Diversion:** A429, A422, A439, A3400, A429 and vice versa.

NB: There will be no access to the A429 from adjoining roads whilst works are being carried out.

### **A429 FOSSE WAY, TREDDINGTON**

**Order Effect:** A 40mph speed restriction will be imposed from a point 150m north of jct of D6567 Village Road to a point 5m north of jct of D6573 Blackwell Road. In addition, a 10mph speed restriction will be effective weekdays only while works are in progress from layby (opp. Electrical Sub Station) in a northerly direction for 3/4km to the camera/parking sign. (managed via signage and convoy vehicles 9.30hrs-15.30hrs).

**Reason for Order:** For the safety of all road users and of the contractors working on the carriageway.

**Order Commences:** 30 November 2020 for up to 18 months.

**Anticipated Completion:** 8 December 2020.
