

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **PUBLIC FOOTPATHS SD29A IN THE PARISH OF CLIFFORD CHAMBERS**

**Order Effect:** Footpath closed to all traffic at grid reference SP1770-5282.

### **D5480 WATERLOO CRESCENT, BIDFORD ON AVON**

**Order Effect:** Road closed to vehicular traffic in its entirety from its junction with Waterloo Road.

**Reason for Order:** To enable footway reconstruction and associated works, 08.00-17.00hrs weekdays only.
