

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

B439 EVESHAM ROAD/BORDON HILL, STRATFORD-UPON-AVON

Order Effect:

Road closed to vehicular traffic from its junction with Luddington Road to its junction with Luddington Lane. **A 40mph speed restriction** will be imposed from outside Stratford Car Centre to the entrance to Dodwell Trading Estate.

Reason for Order: Carriageway closed for resurfacing and associated works, overnight 20.00hrs-06.00hrs weeknights only. Speed restriction imposed for the safety of all road users – effective 24 hours daily.

Order Commences: 11 January 2021 for up to 18 months.

Anticipated Completion: 27 January 2021.

LANE, WHICHFORD

Order Effect: Roads closed to vehicular traffic from Whichford Road/Barrats Hill to Hack Lane.

A439 WARWICK ROAD, HATTON ROCK, HAMPTON LUCY

Order Effect: Speed Restrictions will be imposed as follows:

30 mph – from the junction of Ingon Lane to a point 200 metres past Stratford Road.

10 mph (for convoy working) – from a point 300 metres north of Ingon Lane to a point 100 metres south of Stratford Road.

Reason for Order: Temporary speed restrictions are required for the safety of the work force and all other road users to allow a Convoy method of Traffic Management, 09.30hrs-15.30hrs while carriageway patching and associated works are completed.
