

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **BISHOPTON LANE, STRATFORD UPON AVON**

**Order Effect:** Road closed to vehicular traffic from points either side of Stratford upon Avon canal bridge.

**Reason for Order:** For the installation of a pedestrian crossing and shuttle traffic signals.

**Order Commenced:** 18 January 2021 for up to 18 months. Unfortunately, works were delayed but have now been rescheduled to commence 22 March 2021 with anticipated completion on 30 April 2021.

**Access & Diversion:** Bishopton Lane, Glebe Road, Drayton Avenue, Footpath from Square Off Drayton Avenue, Bromford Way, Masons Road, Timothys Bridge Road (and vice versa).

### **C48 WIMPSTONE LANE, ALDERMINSTER, C48 ILMINGTON ROAD (REDHILL BANK) & C48 STRATFORD ROAD, WHITCHURCH**

**Order Effect:** Roads closed to vehicular traffic as follows: Wimpstone Lane, Alderminster closed between its jcts with A3400 Shipston Road and Wimpston Road. Ilmington Road (Redhill Bank) & Stratford Road, Whitchurch closed between jcts with Wimpstone Road and Crimscoote Road.

**Reason for Order:** Carriageway patching and associated works, 09.00hrs-15.00hrs.

**Order Commences:** 16 March 2021 for up to 18 months.

**Anticipated Completion:** 16 March 2021.

**Access & Diversion:** A3400, Halford Road, Ilmington Road, Armscote Road, Stratford Road, Ilmington Road (Redhill Bank) and vice versa. D6536 Wimpstone Road to remain open.

### **C93 THE RIDGEWAY, STRATFORD-UPON-AVON**

**Order Effect:** Road closed to vehicular traffic between its junctions with A422 Alcester Road and Bishopton Lane.

**Reason for Order:** Carriageway patching and associated works, 09.30hrs-15.30hrs.

**Order Commences:** 17 March 2021 for up to 18 months.

**Anticipated Completion:** 17 March 2021.

**Access & Diversion:** Bishopton Lane, Glebe Road, Mount Crescent, A422 Alcester Road and vice versa.

### **D6465 OLD TREE LANE, UPPER TYSOE**

**Order Effect:** Road closed to vehicular traffic from its junction with Main Street to a point outside The Willows.

**Reason for Order:** Carriageway patching and associated works, 08.00hrs-16.00hrs.

**Order Commences:** 18 March 2021 for up to 18 months.

**Anticipated Completion:** 18 March 2021.

**Access & Diversion:** Main Street, Baldwins Lane and vice versa.

### **THE GREEN & GOSPEL OAK LANE, SNITTERFIELD**

**Order Effect:** Roads closed to vehicular traffic in phases as follows: The Green closed from its junction with Gospel Oak Lane 15 March - 19 March 2021 and Gospel Oak Lane closed between Stratford Armouries and The Green 18 March - 9 April 2021.

**Reason for Order:** To enable works for the installation of a new rising main.

**Order Commences:** 15 March 2021 for up to 18 months.

**Anticipated Completion:** 9 April 2021.

**Access & Diversions:** 1. The Green, Bearley Road, Snitterfield Road, Birmingham Road, Gospel Oak Lane and vice versa. 2. Gospel Oak Lane, Birmingham Road, Stratford Northern Bypass, A46 J A3400 Roundabout, A46 From J A3400 To J A439, Old Kings Lane and vice versa.

### **HOLBROOK ROAD, STRATFORD UPON AVON**

**Order Effect:** Road closed to vehicular traffic between its junctions with Hillside Road and Blacon Way.

**Reason for Order:** To enable repairs to a water pipe.

**Order Commences:** 16 March 2021 for up to 18 months.

**Anticipated Completion:** 18 March 2021.

**Access & Diversion:** Hillside Road, Bishops Close, Sidelands Road, Holbrook Road and vice versa.

### **WALTON ROAD, WELLESBOURNE**

**Order Effect:** Road closed to vehicular traffic from points approximately 20 metres either side of the railway bridge.

**Reason for Order:** To enable a safety structural examination of the disused railway bridge, 08.00hrs-17.00hrs.

**Order Commences:** 15 March 2021 for up to 18 months.

**Anticipated Completion:** 15 March 2021.

**Access & Diversion:** Walton Road, Fosse Way, Bowshot Island, Friz Hill, Kineton Road, Church Street, Bridge Street, Chestnut Square, Ettington Road, Village Road and vice versa.

**Contractor:** Network Rail, Tel: 01132 775 360.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
