

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### CAMPDEN ROAD, STRATFORD UPON AVON

**Order Effect:** Road closed to vehicular traffic from a point 320m north of the centre line of its junction with Tailor Lane to a point 35m south of the centre line of its junction with Tailors Lane.

**Reason for Order:** Construction of culvert extension.

**Order Commences:** 7 April 2021 for up to 18 months.

**Anticipated Completion:** 13 April 2021.

**Access & Diversion:** Campden Road, Station Road, Long Marston Road, Mickleton To Long Marston Road, Long Marston Lane, Stratford Road and vice versa.

### CLOPTON ROAD, STRATFORD UPON AVON

**Order Effect:** Road closed to vehicular traffic between properties number 35 and 39.

**Reason for Order:** To enable new water connections.

**Order Commences:** 6 April 2021 for up to 18 months.

**Anticipated Completion:** 8 April 2021.

**Access & Diversion:** Clopton Road, Justins Avenue, Birmingham Road and vice versa.

### PUBLIC FOOTPATH BETWEEN ALCESTER ROAD & REDLANDS CRESCENT, STRATFORD UPON AVON

**Order Effect:** Footpath closed to all traffic.

**Reason for Order:** To enable the installation of a new electricity cable.

**Order Commences:** 5 April 2021 for up to 6 months.

**Anticipated Completion:** 16 April 2021.

**Access & Diversion:** Redlands Crescent, East Green Drive, Alcester Road and vice versa.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

### A3400 SHIPSTON ROAD, B4632 CLIFFORD LANE, A4390 SEVERN MEADOWS ROAD & A4390 TRINITY WAY, STRATFORD UPON AVON

**Order Effect:** A 30 mph speed limit will be effective on the lengths of road as indicated below:

**A3400 Shipston Road** from a point 250 metres south of Shipston Road/Clifford Lane roundabout to a point 50 metres north of the Shipston Road/Trinity Road roundabout.

**B4632 Clifford Lane** from the roundabout at its junction with Shipston Road westerly for a distance of 160 metres.

**A4390 Severn Meadows Road** from the roundabout at its junction with Shipston Road westerly for a distance of 120 metres.

**A4390 Trinity Way** from the roundabout at its junction with Shipston Road easterly for a distance of 200 metres.

**Reason for Order:** For the safety of all road users and of the Contractors working on the carriageways.

**Order Commences:** 19 April 2021 for up to 18 months.

**Anticipated Completion:** 19 November 2021.

### AVON CRESCENT, STRATFORD UPON AVON

**Order Effect:** Road closed to vehicular traffic between its junctions with Dale Avenue.

**Reason for Order:** To enable a water pipe renewal.

**Order Commences:** 20 April 2021 for up to 18 months.

**Anticipated Completion:** 22 April 2021.

**Access & Diversion:** Avon Crescent, Dale Avenue and vice versa.
