## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### DARLINGSCOTE ROAD, BLACKWELL

**Order Effect:** Road closed to vehicular traffic from a point opposite Blackwell Business Park.

**Reason for Order:** To enable works for a new water connection.

**Order Commences:** 10 May 2021 for up to 18 months.

**Anticipated Completion:** 12 May 2021.

**Access & Diversion:** Darlingscote Road, Shipston Road, Tredington Road and vice versa.

### FORD LANE, LANGLEY

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To enable works for the structural repairs to the bridge.

**Anticipated Completion:** 19 May 2021.

**Access & Diversion:** Ford Lane, Main Street, Langley Road, Church Road, Station Road, Saddle Bow Lane, Saddlebow Lane, Salters Lane and vice versa.

### PUBLIC FOOTPATHS SD2 IN THE PARISH OF STRATFORD UPON AVON

**Order Effect:** Footpath closed to all traffic between Grid References SP18263-56097 and SP18081-56223.

**Reason for Order:** To avoid the likelihood of danger to the public because of excavation works on or near to the footway.

**Order Commenced:** 9 November 2020 for up to 6 months. However, the Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has determined that the order shall continue in force until 9 November 2021 or until the works to which it relates are completed, whichever is the sooner (unless the Secretary of State issues a further direction).

**Access & Diversion:** An alternative route will be appropriately signed.

### WALTON ROAD, WELLESBOURNE

**Order Commences:** 27 May 2021 for up to 18 months.

**Anticipated Completion:** 27 May 2021.
