PROHIBITION OF VEHICLES (EXCEPT PEDAL CYCLES) Sand Barn Lane/A439 Warwick Road, Stratford On Avon (i) to prohibit vehicles (with the exception of pedal cycles using a cycle access) from entering Sand Barn Lane, Stratford on Avon, from its junction with the A439, Warwick Road, Stratford on Avon.

Sand Barn Lane/A439 Warwick Road, Stratford On Avon (ii) permit a left turn only (with the exception of pedal cycles using a cycle access) from Sand Barn Lane, Stratford on Avon, travelling in a north easterly direction, onto the A439 Warwick Road, Stratford on Avon.
