

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

OLD ROAD, SHIPSTON ON STOUR

Order Effect: Road closed to vehicular traffic.

Reason for Order: To enable works for the installation of new water connections.

Order Commences: 29 September 2021 for up to 18 months.

Anticipated Completion: 1 October 2021.

Access & Diversion: Oakham Road, Old Hill, Old Road, Oxford Road, Rollright Road and vice versa.

Order Effect: Road closed to vehicular traffic between its junction with Blackwell Road and a point outside 1 Ladle Farm Cottage (jct. Armscote Road).

SNITTERFIELD LANE, SNITTERFIELD

Order Effect: Road closed to vehicular traffic from a point outside the sewage pumping station to Bell Brook Farm.

Anticipated Completion: 22 October 2021.

Access & Diversion: Snitterfield Lane, Pigeon Green, Park Lane, Kings Lane, Stratford Northern Bypass, A46 from J A3400 to J A439, Heath End and vice versa.

WATERY LANE, PILLERTON HERSEY

Order Effect: Road closed to vehicular traffic from a point outside Rosedale across carriageway to a point outside Staddle Stones and across carriageway to Arun House to a point outside The Paddock.

Reason for Order: To enable works to build 1 recast jointing chamber and installation of polyduct.

Order Commences: 11 October 2021 for up to 18 months.

Anticipated Completion: 22 October 2021.
