

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A3400 SHIPSTON ROAD, STRATFORD-UPON-AVON

Order Effect: Road closed to vehicular traffic between the Clifford Lane roundabout and D6511 Atherstone Road.

Reason for Order: Carriageway patching and associated works, overnight 20.00hrs-06.00hrs.

Order Commences: 25 November 2021 for up to 18 months.

Anticipated Completion: 28 November 2021.
