

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

C48 STRATFORD ROAD, C48 FRONT STREET, C49 MICKLETON ROAD AND C49 ARMSCOTE ROAD, ILMINGTON

Order Effect: Road closed to vehicular traffic as follows: **Stratford Road** closed between its junctions with Admington Road and Front Street, **Front Street** closed between its junctions with Stratford Road and Washbrook Place, **Mickleton Road** closed between its junctions with Front Street/Stratford Road and Back Street, and **Armscote Road** closed between its junctions with Front Street and Darlingscote Road.

Reason for Order: Drainage works, carriageway resurfacing and associated works, 09.30hrs-15.30hrs weekdays only.

Order Commences: 29 November 2021 for up to 18 months.

Anticipated Completion: 10 December 2021.

Access & Diversions:

Stratford Road/Armscote Road/Front Street Diversion: Stratford Road (Redhill Bank), Ilmington Road, Wimpstone Lane, A3400, Halford Road, Ilmington Road (Armscote), Armscote Road, Darlingscote Road, Featherbed Lane, Washbrook Place and vice versa.

Stratford Road/Mickleton Road Diversion: As above – traffic to use Admington Road, Meon Hill, Admington Lane, Park Lane, Mickleton Lane and vice versa from Stratford Road (Redhill Bank).

Order Effect: Road closed to vehicular traffic.
