

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **BARTON ROAD, WELFORD ON AVON**

**Order Effect:** Road closed to vehicular traffic between its Hunt Hall Lane and Avon View Farm.

**Reason for Order:** To create a safe environment for engineers working on overhead structures.

**Order Commences:** 5 January 2022 for up to 18 months.

**Anticipated Completion:** 5 January 2021.

**Access & Diversion:** Barton Road, Long Marston Road, Welford Road, Main Street, Pear Tree Close, Dorsington Road, Braggington Lane, High Street, Chapel Street and vice versa.

### **BEARLEY ROAD, SNITTERFIELD**

### **SPRING LANE, LANGLEY**

**Order Effect:** Road closed to vehicular traffic.

**Anticipated Completion:** 30 January 2022.

**Access & Diversion:** Fordham Avenue, Maidenhead Road, Blackthorn Road, St Marys Road and vice versa.

### **A3400 BIRMINGHAM ROAD, A3400 GUILD STREET, D6108 SHAKESPEARE STREET & C77 WINDSOR STREET, STRATFORD UPON AVON**

**Order Effect:** Roads closed to vehicular traffic as follows: **Birmingham Road** closed between Arden Street and Guild Street, **Guild Street** closed from A3400 roundabout to a point outside the One Elm car park, **Shakespeare Street** closed from A3400 roundabout into the bell-mouth adjacent to the side of the One Elm Public House, and **Windsor Street** closed from A3400 roundabout to a point outside Shakespeare's Birthplace Coach Terminal Kiosk (One-way traffic flow temporarily suspended to allow access to/egress from carpark).

### **C76 WOOD STREET, STRATFORD UPON AVON**

**Order Effect:** Road closed to vehicular traffic between its junctions with Market Cross Roundabout and Meer Street.

**Anticipated Completion:** 20 February 2022.

**Access & Diversion:** Anti-clockwise: A3400 New Street, B4035 West Street and Old Road. Clockwise: Old Road, B4035 West Street, A3400 Church Street and A3400 New Street.
