

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A422 ALCESTER ROAD, STRATFORD UPON AVON

Order Effect: Road closed to vehicular traffic between Long Acre Drive and the Texaco Garage.

Reason for Order: To enable tenable resurfacing of new road junction. **Please Note:** Works will be carried out over two consecutive weekends, 12/02/22 to 13/02/22 and 19/02/22 to 20/02/22.
