

## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **A3400 SHIPSTON ROAD, ATHERSTONE ON STOUR/ PRESTON ON STOUR**

**Order Effects:** Road closed to vehicular traffic between the entrance to Atherstone Industrial Estate/Grove Business Park and the entrance to Monks Barn Farm. In addition, a speed limit of 40mph will be imposed from a point 100 yards north of D6511 Atherstone Road to a point 100 yards south of Atherstone Industrial Estate/Grove Business Park.

**Reasons for Order:** Closure – Carriageway resurfacing and associated works, overnight 20.00hrs-06.00hrs, weeknights. Temporary 40 mph speed limit – 24hrs every day for the safety of all road users when the road is open.
