

**ROAD TRAFFIC REGULATION ACT 1984**

**Warwickshire County Council has made the following Temporary Traffic Orders:**

**CHAPEL LANE, STRATFORD UPON AVON**

**Order Effect:** Road closed to vehicular traffic from a point adjacent to the Guild Hall.

**Reason for Order:** To enable works for the installation of polyethylene cable.

**Order Commences:** 20 June 2022 for up to 18 months.

**Anticipated Completion:** 22 June 2022.

**Access & Diversion:** Chapel Lane, Waterside, Sheep Street, Chapel Street and vice versa. The One-way traffic flow on Chapel Lane will be temporarily suspended to allow access/egress for residents and businesses only.
