

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

BISHOPTON LANE, STRATFORD UPON AVON

Order Effect: Road closed to vehicular traffic in two phases as follows: 1. Between its junctions with Glebe Road and Heron Lane for surfacing 11 July - 25 July 2022; and 2. between points either side of the canal bridge for signal works 1 August - 12 August 2022.

THE WARWICKSHIRE COUNTY COUNCIL (A439 WARWICK ROAD/SAND BARN LANE, STRATFORD ON AVON) (LEFT TURN ONLY) ORDER 2022

Warwickshire County Council has made the above-named Orders under the Road Traffic Regulation Act 1984, the effect of which prohibits vehicles from entering, and to permit a left turn only, on the lengths of roads and as described in the schedule below.

The Order commences on Monday, 11th July 2022.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

SCHEDULE

PROHIBITION OF VEHICLES (EXCEPT PEDAL CYCLES)

Sand Barn Lane/A439 Warwick Road, Stratford On Avon

- (i) to prohibit vehicles (with the exception of pedal cycles using a cycle access) from entering Sand Barn Lane, Stratford on Avon, from its junction with the A439, Warwick Road, Stratford on Avon

LEFT TURN ONLY (EXCEPT PEDAL CYCLES)

Sandbarn Lane/A439 Warwick Road, Stratford On Avon

- (ii) permit a left turn only (with the exception of pedal cycles using a cycle access) from Sand Barn Lane, Stratford on Avon, travelling in a north easterly direction, onto the A439 Warwick Road, Stratford on Avon.
