

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **BROAD STREET, STRATFORD UPON AVON**

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To enable works for the renewal of a water pipe.

**Order Commences:** 22 August 2022 for up to 18 months.

**Anticipated Completion:** 25 August 2022.

**Access & Diversion:** Broad Walk, Evesham Place, Evesham Road, Chestnut Walk and vice versa.

### **C107 HARROW HILL, LONG COMPTON**
