

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

### **B4035 WEST STREET/CAMPDEN ROAD & D6607 OLD ROAD, SHIPSTON ON STOUR**

**Order Effect:** Road closed to vehicular traffic as follows: West Street/Campden Road closed from its junction with the A3400 New Street to a point outside 38 Campden Road; Old Road closed from its junction with West Street for a distance of 10 metres.
