

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **B4035 WEST STREET/CAMPDEN ROAD & D6607 OLD ROAD, SHIPSTON ON STOUR**

**Order Effect:** Roads closed to vehicular traffic as follows: West Street/Campden Road closed from its junction with the A3400 New Street to a point outside 38 Campden Road. Old Road closed from its junction with West Street for a distance of 10 metres.

**Reason for Order:** Carriageway resurfacing and associated works.

**Order Commences:** 11 September 2022 for up to 18 months. Work will be carried out in phase, weekdays 09.00-15.30hrs and Sunday 11 September 08.00hrs-16.00hrs.
