

## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **BACK LANE, TREDINGTON**

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To enable works for installation of tobies and laying of duct.
