

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

C54 TYSOE ROAD, KINETON

Order Effect: Road closed to vehicular traffic between its junctions with the C53 Oxhill Road and A422 Stratford Road (Banbury Road).

Reason for Order: For public safety as the carriageway is unsafe due to collapse as a result of burrowing wildlife.

Order Commences: 3 February 2023 for up to 18 months.

Access & Diversion: Oxhill Road, A422 Stratford Road (Banbury Road) and vice versa.
