

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **CAMPDEN ROAD, STRATFORD UPON AVON**

**Order Effect:** Road closed to vehicular traffic.
