

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A429 FOSSE WAY, STRETTON ON FOSSE

Order Effect: Road closed overnight to vehicular traffic between its junction with the B4035 Campden Road and the County Boundary. In addition, a 40 mph Speed Limit will be enforced 24 hours daily from the County Boundary Signs to the entrance of sewage treatment works opposite Station House (both Northbound and Southbound carriageways) when the road is in use.

Reason for Order: Carriageway resurfacing, patching and associated works, overnight 20.00hrs-06.00hrs. Speed Restriction necessary for the safety of all road users.
