

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **B4455 FOSSE WAY, COMPTON VERNEY/MORETON MORRELL**

**Order Effect:** Road closed to vehicular traffic overnight, 20.00hrs-06.00hrs, between B4086 Compton Hill/Frizz Hill Roundabout and C96 Wellesbourne Road both Northbound & Southbound carriageways. In addition, a 40mph speed limit will be imposed until all works are completed.

**Reason for Order:** Carriageway resurfacing and associated works, overnight. 40mph Speed Restriction 24 hours daily for the safety of all road users when road is open.

**Order Commences:** 30 May 2023 for up to 18 months.

**Anticipated Completion:** 10 June 2023.

**Reason for Order:** Footpath reconstruction and associated works.

**Order Commences:** 30 May 2023 for up to 6 months.

**Anticipated Completion:** 16 June 2023.

**Access & Diversion:** Clopton Road, Verney Drive, Flower Avenue and Burbage Avenue. No Access from Clopton Road, Sycamore Close, Flower Road, Gilbert Close, Sadler Close and Burbage Avenue.

### **C46 BINTON BRIDGE, BINTON ROAD, WELFORD ON AVON**
