

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **B4100 BANBURY ROAD, GAYDON**

**Order Effect:** The approach lane to Jaguar Land Rover on B4100 Banbury Road, Gaydon will be closed to vehicular traffic from the Cycle Way on Warwick Road to the British Motor Museum. In addition, vehicular traffic will be prohibited from making a Left Turn from Banbury Road into The Heritage Centre.

**Reason for Order:** To safely enable works for laying of HV Cable.

**Order Commences:** 28 June 2023 for up to 18 months.

**Anticipated Completion:** 1 August 2023.

**Order Commences:** 1 January 2023 and was due to expire on 30 June 2023. **However, the Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has directed that the Order shall continue in force until 1 January 2024 or until works are completed, whichever is the earlier (unless the Secretary of State issues a further direction).**
