

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### A429 FOSSE WAY, STRETTON ON FOSSE

**Order Effect:** Temporary speed restrictions will be imposed as follows: **Temporary 40 mph Speed Limit** – From D6562 Blackwell Road (Village Road) in a southerly direction to B4035 Campden Road (north and southbound carriageways), **Temporary 10 mph Speed Limit** – From a point 140 metres from the entrance to Holt House for a distance of 210 metres in a southerly direction (north and southbound carriageways).

### THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. D) ORDER 2024

Warwickshire County Council has made the above-named order as advertised in its Public Notices dated 09 December 2022 and 20 October 2023, relating to the above-named Variation Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing District of Stratford on Avon (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 as described in the Schedule 1 and Schedule 2 below.

The Order commences on Monday 22 January 2024.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.

#### **SCHEDULE 1**

**(No Waiting at Any Time)**

**(To both sides of the road unless stated otherwise)**

#### B4035 Campden Road

(i) From a point 32m south west of a line between the two westernmost property boundary lines of the properties known as Blue Gate and No 14 Oldbutt Road, then in a generally south westerly direction to a point 12m west of the centre line of Webb Road. A distance of 230m.

#### Bailey Road

(ii) From a point in line with the Back of Footway on the southern side of the B4035, then in a south easterly direction on both sides of Bailey Road for a distance of 29.5m.

#### Nason Way

(iii) From a point in line with the front elevation of property No1 Nason Way.  
(a) Western side only, north to the property boundaries of No 1 and 2 Nason Way, a distance of 9.4m  
(b) Eastern side only, north for a distance of 12.5m  
(c) Both sides, south to its junction with the B4035

#### Webb Road

(v) From a point in line with the Back of Footway on the south side of Campden Road, then in a southerly direction for a distance of 8m.

#### **SCHEDULE 2**

**No Stopping Except in Emergency**

**(Maintenance Layby)**

#### B4035 Campden Road

From a point 21m east of the centre line of Webb Road, then in an easterly direction for a distance of 20m, on the northern side of Campden Road only.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
